



CITY OF SOUTH TUCSON RESOLUTION NO: 15-10

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SOUTH TUCSON, ARIZONA, APPROVING AND ADOPTING THE AGREEMENT BETWEEN THE CITY OF SOUTH TUCSON (“CITY”) AND CLIMATEC (“CONTRACTOR”), FOR INSTALLATION OF SECURITY CAMERAS AND RELATED SYSTEM UPGRADES AT THE CITY OF SOUTH TUCSON HOUSING AUTHORITY ADMINISTRATIVE OFFICES MAINTAINED BY THE SOUTH TUCSON HOUSING AUTHORITY, AUTHORIZING THE MAYOR AND/OR THE CITY MANAGER TO EXECUTE THE AGREEMENT

WHEREAS, the City of South Tucson, is authorized and empowered to have control of the finances, property and employees of the corporation and to have power within the limits of the City to oversee all phases of services to the citizens of the City pursuant to Title 9, A.R.S. §§ 9-240 and 9-499.01 et seq.; and

WHEREAS, the CITY, by the South Tucson Housing Authority and it's Director recommend approval to enter into a contract for replacement of security cameras and related system upgrades with the CONTRACTOR; and

WHEREAS, the CITY and the CONTRACTOR have negotiated an Agreement for above noted services as provided therein in the amount of nine thousand four hundred fifty eight dollars and twenty four cents (\$9,458.24); and

WHEREAS, the AGREEMENT was necessary for the health and safety of the residents of the effected Housing projects and was entered into by the South Tucson Housing Authority prior to Council approval; and

WHEREAS, the Parties desire to have this item presented at the next City of South Tucson Council Meeting on February 23, 2015; and

WHEREAS, the Mayor and Council have determined that it is in the best interest of the City of South Tucson and its citizens to approve, ratify and to adopt this AGREEMENT as presented; and

BE IT RESOLVED by the Mayor and Council of the City of South Tucson, Arizona, as follows:

Section 1: The Mayor and Council formally approve and adopt the AGREEMENT with CONTRACTOR as presented.


Section 2: The Mayor and/or the City Manager are hereby authorized to execute said Agreement.
