



CITY OF SOUTH TUCSON RESOLUTION NO: 15-11

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SOUTH TUCSON, ARIZONA, APPROVING THE INTERGOVERNMENTAL AGREEMENT [IGA] FOR ASSISTANCE IN THE PREPARATION AND CONDUCT OF A RECALL ELECTION TO BE HELD ON MAY 19, 2015 BETWEEN THE CITY OF SOUTH TUCSON, ARIZONA [CITY] AND PIMA COUNTY RECORDER'S OFFICE THROUGH THE DIVISION OF ELECTIONS [COUNTY RECORDER] PURSUANT TO STATUTE AND AUTHORIZING EXECUTION OF THIS RESOLUTION, FOR THE PURPOSE OF AUTHORIZING THE MAYOR OF THE CITY OF SOUTH TUCSON TO EXECUTE SAID IGA

WHEREAS, the COUNTY RECORDER and the CITY are authorized and desire to enter into an IGA pursuant to ARS ' ' 9-231(A); 16-205(C); 16-172, 16-408(D); 16-450; 16-405; 11-251(3); 11-952, *et seq.*; and

WHEREAS, the COUNTY RECORDER currently provides election services county wide through the Division of Elections and is capable and willing to provide services to the CITY with respect to the May 19, 2015 Recall Election to be held by the City of South Tucson, Arizona; and

WHEREAS, the Parties desire to have this item presented to the South Tucson Mayor and City Council at its next regular meeting on Monday, March 9, 2015; and

WHEREAS, the Mayor and Council of the City of South Tucson have determined that it is in the best interest of the CITY and its residents to enter into an IGA with the COUNTY RECORDER for the period effective March 31, 2015 through the completion of all obligations and activities contemplated by this IGA and/or the final resolution of any legal challenge to the election; and

WHEREAS, it is necessary for the preservation of the peace, health, and safety of the City of South Tucson, Arizona, that an emergency be declared to exist, and that

this Resolution be effective immediately upon its passage and adoption.

THEREFORE BE IT RESOLVED by the Mayor and Council of the City of South Tucson, Arizona, that the CITY hereby gives formal approval for the execution of said IGA and empowers the Mayor of the City of South Tucson to execute said document.


