

CITY OF SOUTH TUCSON RESOLUTION NO: 13-29

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SOUTH TUCSON, ARIZONA, APPROVING, RATIFYING AND ADOPTING THE AGREEMENT BETWEEN THE CITY OF SOUTH TUCSON ("CITY") AND ANDREA L. DE CASTILLO ("ATTORNEY") FOR EMPLOYMENT AS THE CITY ATTORNEY, AUTHORIZING THE MAYOR TO EXECUTE THE AGREEMENT.

WHEREAS, the Mayor and Council of the City of South Tucson, pursuant to the South Tucson City Code Sections 2-52(a),(b), 2-58., shall appoint a City Attorney to oversee the legal operations of the City ; and

WHEREAS, the CITY and the ATTORNEY desire to enter into an AGREEMENT for the ATTORNEY'S employment with the CITY; and

WHEREAS, the CITY and the ATTORNEY have negotiated an Agreement for the noted services and benefits included in the AGREEMENT for a term to run from September 1, 2013 to August 31, 2015, with a provision to extend the AGREEMENT upon mutual consent of the parties; and

WHEREAS, the Parties desire to have this item presented at the next City of South Tucson Council Meeting on September 9, 2013; and

WHEREAS, the Mayor and Council have determined that it is in the best interest of the City of South Tucson and its citizens to approve, ratify and to adopt this AGREEMENT as presented; and


BE IT RESOLVED by the Mayor and Council of the City of South Tucson, Arizona, as follows:




OATH OF OFFICE
