



CITY OF SOUTH TUCSON RESOLUTION NO. 13-42

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SOUTH TUCSON, ARIZONA, RATIFYING, APPROVING, AND ADOPTING THE FY 2012-2013 JOHN A. VALENZUELA YOUTH CENTER RECREATION FUNDING AGREEMENT [“AGREEMENT”] BETWEEN THE CITY OF SOUTH TUCSON, ARIZONA [“CITY”] AND THE PIO DECIMO CENTER, A NON-PROFIT CORPORATION [“AGENCY”] AND AUTHORIZING EXECUTION OF THIS RESOLUTION FOR THE PURPOSE OF AUTHORIZING THE MAYOR AND/OR THE CITY MANAGER OF THE CITY OF SOUTH TUCSON TO EXECUTE SAID “AGREEMENT” AND DECLARING AN EMERGENCY TO EXIST

WHEREAS, the City of South Tucson is a municipal corporation that supports the use of the John A. Valenzuela Youth Center for public youth services; and

WHEREAS, the City will provide South Tucson residents of Pima County year-round youth programs at the John A. Valenzuela Youth Center; and

WHEREAS, the City desires to support recreational activities that confer a direct benefit to the Pima County residents of the City of South Tucson; and

WHEREAS, the City of South Tucson has received Pima County Recreation Department funds for FY 2012-2013 to continue to provide aid to the youth in engaging in crafts, organized games, and other forms of recreation at the John Valenzuela Center through Pio Decimo Center “AGENCY”.

WHEREAS, the City of South Tucson desires to have this item presented to the South Tucson Mayor and City Council at its next regular meeting on October 30, 2013; and

WHEREAS, the term of this agreement is from October 1, 2012 to December 31, 2013 and the allocation amount is increased to an amount not to exceed One Hundred Thousand Dollars (\$100,000.00); and

WHEREAS, the Mayor and Council of the City of South Tucson have determined that it is in the best interest of the "CITY" and the youth in this community to enter into "AGREEMENT" with the "AGENCY" for the Pima County funding cycle of October 1st, 2012 to September 30th, 2013; and

WHEREAS, it is necessary for the preservation of the peace, health, and safety of the City of South Tucson, Arizona, that an emergency be declared to exist, and that this Resolution be effective immediately upon its passage and adoption.

BE IT RESOLVED by the Mayor and Council of the City of South Tucson, Arizona, that the City hereby gives formal approval and ratification for the execution of said "AGREEMENT" and empowers the Mayor of the City of South Tucson to execute said document.

BE IT FURTHER RESOLVED by the Mayor and Council of the City of South Tucson, Arizona, that, due to an existing emergency declared herein, the immediate effectiveness of this Resolution is necessary to preserve the peace, health, and safety of the City of South Tucson, Arizona, and this Resolution shall therefore be effective upon its passage and adoption.
