

CITY OF SOUTH TUCSON RESOLUTION NO: 13-35

RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SOUTH TUCSON, ARIZONA, APPROVING AND ADOPTING REVISIONS TO THE SOUTH TUCSON PUBLIC HOUSING AUTHORITY'S ("PHA") POLICIES IN THE ADMINISTRATIVE PLAN FOR THE HOUSING CHOICE VOUCHER PROGRAM ("SECTION 8") AND AUTHORIZING THE MAYOR TO EXECUTE THIS RESOLUTION FOR THE PURPOSE OF AUTHORIZING THE STHA DIRECTOR TO SUBMIT SAME TO HUD AND DECLARING AN EMERGENCY TO EXIST

WHEREAS, the South Tucson Mayor and Council, on behalf of the South Tucson Housing Authority is required to review and approve the Public Housing Authority's Administrative Plan and Revisions thereto; and

WHEREAS, the South Tucson Housing Authority is funded through the US Department of Housing and Urban Development and is required to submit Policy Revisions to the PHA Administrative Plan; and

WHEREAS, the Mayor and Council of the City of South Tucson have determined that it is in the best interest of the City and its residents to approve and adopt the PHA Administrative Plan Revisions to the Section 8 Program under the attached chapters; and

WHEREAS, the Mayor and Council of the City of South Tucson desires to have this item presented at its September 25, 2013 Council Meeting; and

WHEREAS, it is necessary for the preservation of the peace, health, and safety of the City of South Tucson, Arizona, that an emergency be declared to exist to assure timely submittal of Revisions to the Administrative Plan to HUD, and that this Resolution be effective immediately upon its passage and adoption.

BE IT RESOLVED by the Mayor and Council of the City of South Tucson, Arizona, that the City hereby formally approves and adopts the STHA Administrative Plan Revisions to the Section 8 Program under the attached Chapters as presented.

BE IT FURTHER RESOLVED by the Mayor and Council of the City of South Tucson, Arizona, that, due to an existing emergency declared herein, the immediate effectiveness of this Resolution is necessary to preserve the peace, health, and safety of the City of South Tucson, Arizona, and this Resolution shall therefore be effective upon its passage and adoption.


