

SOUTH TUCSON RESOLUTION NO: 13-48

RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SOUTH TUCSON, ARIZONA APPROVING AND DIRECTING THE CITY MANAGER TO EXECUTE AWARD TO FESTER AND CHAPMAN, P.C. FOR THE REQUEST FOR PROPOSAL FOR THE CITY SOUTH TUCSON ANNUAL INDEPENDENT AUDIT SERVICES FOR FISCAL YEAR 2012-2013; AUTHORIZING THE MAYOR TO EXECUTE THIS RESOLUTION AND THE PROPOSAL DOCUMENTS

WHEREAS, the South Tucson Mayor and Council, on behalf of the South Tucson City Manager has invited qualified independent public accountants to submit proposals for the performance of annual audit of its financial accounts and records covering the period of July 1, 2012 through June 30, 2013 with possible renewals for the next two fiscal years

WHEREAS, the City of South Tucson bid opening was conducted on November 22, 2013; and

WHEREAS, City Manager and City administrative staff has reviewed and conducted interviews for audit services on December 9, 2013; and

WHEREAS, the Mayor and Council of the City of South Tucson have determined that it is in the best interest of the City and its residents to approve and award the Annual Independent Audit Services to Fester & Chapman, P.C. (contractor); and

WHEREAS, The audit shall be conducted to attest to the requirement of the report to the State of Arizona General of the state expenditure limitation in accordance with Arizona Revised Statute 41-1279-.07 for Fiscal Year 2012-2013

WHEREAS, the term of the contract shall commence upon award and shall remain in effect for a period of (1) year, unless terminated, canceled or extended. The contractor agrees to a possible renewal the contract for two (2) additional one (1) year periods or portions thereof;

WHEREAS, it is necessary for the preservation of the peace, health, and safety of the City of South Tucson, Arizona, that an emergency be declared to exist, and that his Resolution be effective immediately upon its passage and adoption.

NOW THEREFORE BE IT RESOLVED that the Mayor and Council of the City of South Tucson, Arizona, approves and awards the request for proposal for the south Tucson Annual Independent Audit Services for Fiscal Year 2012-2013 to Fester & Chapman, P.C. (contractor) and empowers the Mayor to execute Resolution No: 13-48.


