

CITY OF SOUTH TUCSON RESOLUTION NO. 14-02

RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SOUTH TUCSON, ARIZONA, APPROVING THE SOUTH TUCSON HOUSING AUTHORITY'S WRITE-OFF OF UNCOLLECTIBLE DEBTS AND AUTHORIZING THE EXECUTION OF THIS RESOLUTION FOR THE PURPOSE OF AUTHORIZING THE CITY OF SOUTH TUCSON HOUSING AUTHORITY DIRECTOR TO SUBMIT SAME TO HUD AND ITS FEE ACCOUNTANT AND DECLARING AN EMERGENCY TO EXIST

WHEREAS, the South Tucson Mayor and Council, on behalf of the South Tucson Housing Authority (hereinafter "STHA"), are required to review and approve the Housing Authority's write-offs; and

WHEREAS, the STHA is funded through the US Department of Housing and Urban development (HUD) and is required to submit any uncollectible debts by past residents; and

WHEREAS, the Mayor and Council of the City of South Tucson have determined that it is in the best interest of the City and its residents to approve and authorize the STHA's write-offs; and

WHEREAS, the STHA has abided by its approved Write-Off Policy; and

WHEREAS, it is necessary for the preservation of the peace, health, and safety of the City of South Tucson, Arizona, that an emergency be declared to exist, and that this Resolution be effective immediately upon its passage and adoption.

NOW THEREFORE BE IT RESOLVED by Mayor and Council of the City of South Tucson, Arizona, that the City hereby gives formal approval for the STHA's write-off of uncollectible debt as follows:

BE IT FURTHER RESOLVED by the Mayor and Council of the City of South Tucson, Arizona, that, due to an existing emergency declared herein, the immediate effectiveness of this Resolution is necessary to preserve the peace, health, and safety of the City of South Tucson, Arizona, and this Resolution shall therefore be effective upon its passage and adoption.


