

**CITY OF SOUTH TUCSON RESOLUTION NO: 13-24**

**A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF SOUTH TUCSON, ARIZONA APPROVING AND ADOPTING AN EXTENSION OF AGREEMENT NO: 01-11-0-140770-0408 [“IGA”] AMONG THE PIMA COUNTY REGIONAL SPECIAL WEAPONS AND TACTICS TEAM [“PARTICIPATING JURISDICTIONS”] TO EXTEND THE CONTRACT TERM AND TO AUTHORIZE THE MAYOR TO EXECUTE THE AMENDMENT**

**WHEREAS**, the Law Enforcement Participating Jurisdictions of Pima County, City of South Tucson, Town of Oro Valley, Town of Marana, Town of Sahuarita, Pascua Yaqui Tribe, and the Tucson Airport Authority entered into a collective agreement to form and operate the Pima County Regional Special Weapons and Tactics Team (“S.W.A.T.”); and

**WHEREAS**, the CITY passed and adopted Resolution 08-11 to approve the IGA and to authorize the CITY to participate with other Law Enforcement Participating Jurisdictions in the prescribed activities; and

**WHEREAS**, the CITY passed and adopted Resolution 09-57 to approve amendments to the IGA with other Law Enforcement Participating Jurisdictions in the prescribed activities; and

**WHEREAS**, the CITY and the other Law Enforcement Participating Jurisdictions have the authority to enter into agreements for services pursuant to A.R.S. Section 11-951, 11-952, and 48-805 [Intergovernmental Agreements], if authorized by their legislative or governing bodies; and

**WHEREAS**, it is the mutual desire of the parties to extend the term of the IGA contract number 01-11-0-140770-0408 to extend the contract term of the IGA to April 14, 2018, as presented to Mayor and Council; and


**NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF SOUTH TUCSON, ARIZONA, AS FOLLOWS:**

**Section 1:** That the CITY formally approves Resolution 13-24 for the purpose of approving and adopting the extension of the term of the IGA with the Law Enforcement Participating Jurisdictions for services as outlined in the IGA and the Amendment.

**Section 2:** That the Mayor is authorized and empowered to execute this Resolution and the extension of the term of the Intergovernmental Agreement Document as presented.


